Brief summary of allegation: Reporter called to inform that the IC is being released from Piney Ridge, because of complaints they had made about Piney Ridge. It is felt that Piney Ridge is retaliating and discharging IC. It was stated that their child was placed there to complete counseling and that Brad McDaris told her they would keep their son till graduation date, so he would not have to change schools to graduate. Now they are saying he will be finishing the program on Jan. 29th and he will be released from the program. The reporter is concerned that this will cause IC to not be able to complete his senior year of high school.

List all reported injuries to the child: None known

Interim corrective action for this incident: Licensing Specialist visited the facility on 1/14 and reviewed IC's file. IC was still placed at the facility and there was no specific discharge date. Licensing Specialist spoke with Ronissa Adams, who stated the child would continue in treatment until he finished the program that was deemed necessary for him to complete. There was no discharge date of 1/29, at the time of Specialist visit.

Final corrective action narrative: Licensing Complaint is unfounded. As of 2/11/21, IC was still at the Piney Ridge Facility with an expected discharge date of 4/27/21.
