y/o Foster Child that Identities as . The A/o is a peer at Pinev IC1 is Ridge. It was reported that the A/V jumped the fence of the Piney Ridge Residential facility and ran to a nearby home. The AV knocked on the door and explained to the individual that he had been "chained up", sexually assaulted and deprived of water. The individual said that they would contact law enforcement. The A/V then left the home and proceeded to an apartment complex which he stated that he was chained up", sexually assaulted, and deprived of water. Law Enforcement arrived and conversed with the A/V. The AV/disclosed that he was sexually abused while living in Virginia. The A/V also mentioned that he had family in Arkansas but he was not able to give locating information for them. The A/V also disclosed while in the facility at Pine Ridge, staff yelled at him and pushed him against the wall causing him to be scared and wet himself. A/V also disclosed that an unknown peer in the facility asked for sexual favors and the A/V refused. A/V then said the peer rubbed his crotch area. Further details are unknown.
