On January 21, 2019, I, Officer Davis was dispatched to WoodRidge Behavioral Center about an assault report. Upon arrival, contact was made with Mr. Kendal Williams (Youth Care Worker) and [REDACTED] the kid that was assaulted. [REDACTED] stated that on January 21, 2019 at approximately 7:30am he was in opening the door in the lobby and when [REDACTED] seen the door opened he charged the door and came through and started hitting him on the left side of his head and facial area. He then called for help and several staff members rushed into the lobby and broke up the fight. [REDACTED] also stated that during the fight he received injuries to his right arm and his left ear. I, Officer Davis looked at the injuries to [REDACTED] arm and ear, and the injuries look like they were old. Mr. Williams was informed about the Affidavit process and a report was taken, also pictures.
