NARRATIVE

ON TODAY'S DATE I RESPONDED TO THE LISTED LOCATION IN REGARDS TO A DISTURBANCE, UPON MY ARRIVAL I MADE CONTACT WITH MR. WATERS WHO IS A "TEACHING PARENT" AT THE LOCATION. MR. WATERS ADVISED THAT EARLIER ON THIS DATE, JUVENILE 1 WAS HORSE-PLAYING WITH ANOTHER UNKNOWN JUVENILE. MR. WATERS ADVISED ME THAT MS. STEWART WHO IS "SUPPORT STAFF" AT THE LOCATION, TOLD JUVENILE 1 TO STOP HORSE-PLAYING, MR. WATERS ADVISED THAT JUVENILE 1 TOLD MS. STEWART NOT TO YELL AT HIM BECAUSE IT WAS A "TRIGGER". MR. WATERS ADVISED ME THAT ANOTHER JUVENILE (2) THAT LIVES AT THE LOCATION. TOLD JUVENILE 1 NOT TO BE RUDE TO MS. STEWART. MR. WATERS ADVISED ME THAT THIS IS WHEN JUVENILE 1 BECAME VERY UPSET AND STATED HE NEEDED TO LEAVE THE LOCATION BEFORE HE "HURT SOMEONE". JUVENILE 1 DID NOT THREATEN A SPECIFIC PERSON. MS. STEWART AND JUVENILE 2 WERE NOT ON SCENE. I MADE CONTACT WITH JUVENILE 1 WHO WAS CALM. HE TOLD ME WHAT HAPPENED AND STATED HE DIDN'T WANT TO HURT ANYONE OR HIMSELF. HE ADVISED THAT HE JUST GETS ANGRY WHEN PEOPLE YELL AT HIM AND PICK ON HIM. MR. WATERS NOTIFIED METHODIST CHILDRENS HOSPITAL BUT WAS UNABLE TO LOCATE A BED FOR JUVENILE 1. MR. WATER ADVISED HE WOULD ATTEMPT TO ARRANGE DIFFERENT SLEEPING QUARTERS IF POSSIBLE SO THAT JUVENILE 1 AND 2 WOULD NOT HAVE TO SHARE A ROOM FOR THE NIGHT. JUVENILE 1 WAS QUIET AND CALM AND APPEARED CONTENT WITH THE PLAN. I PROVIDED MR. WATERS WITH AN INCIDENT NUMBER. NO OTHER ACTION WAS TAKEN. MVR IN USE 18C468.
