Blackmon advsied time he attempted to restrain him per the facilities protocol to prevent any or staff. Blackmon stated while he was trying to injury from accuring to headbutted him (Blackmon) numerous times in the , he nose and chin. There was what appeared to be swelling to the bridge of Blackmons nose and also appeared to be turning red. I also observed damage to a heating and cooling unit in the room and it appeared as if a piece of the plexi glass window had been knocked out.
