On 02/04/2019, at around 2035hrs, a call came into the Forrest City Police Department in reference to a very aggressive juvenile at the Woodridge Behavioral Facility. Upon my arrival, I could hear a male in a loud and aggressive tone stating to someone, yall better let me up. As I entered the area that housed the juveniles, I could hear where the hollering was coming from, I observed two staff members restraining a white male on the floor. Nurse Jacie Flowers was also in the room. I asked what was going on, Timothy Blackmon the staff member that had the male held down by his arms stated to me [REDACTED] was destroying the day room by throwing chairs against the walls and ceiling. Blackmon advised he told [REDACTED] numerous times to stop what he was doing but to no avail. Blackmon advsied [REDACTED] continued to be aggressive, it was at that time he attempted to restrain him per the facilities protocol to prevent any injury from accuring to [REDACTED] or staff. Blackmon stated while he was trying to restrain [REDACTED], he [REDACTED] headbutted him (Blackmon) numerous times in the nose and chin. There was what appeared to be swelling to the bridge of Blackmons nose and also appeared to be turning red. I also observed damage to a heating and cooling unit in the room and it appeared as if a piece of the plexi glass window had been knocked out. A juvenile affidavit was done by Timothy Blackmon against [REDACTED] for Battery 3rd degree. Nurse Jacie Flowers also wrote a statement as to what she observed.
