On February 7th, 2019, Woodridge called the Forrest City Police Department, and stated that a Juvenile, had ran out of the building and into the woods beside the building, wearing a Camo Pullover, Jeans, Boots, and is described as a white male, with brown hair and no distinctive features.

Upon my arrival, I, Ofc. D. Dowdy made contact with Antonio Sims, VCC, who stated that all he saw was slipping out the door, and by the time he got to the door, had ran into the woods. Mr. Sims stated that there have been no recent incidents that he could remember that would have upset Mr. and that they have not had any prior issues with

Woodridge stated they had not yet contacted the mother, but they would be in the process of doing so shortly. It is said to have no family in the area, all family being located in Batesville. He has been in the facility since December 2018, he is also not said to know anyone in the area, or have a cellphone.
