Narrative & Statements

Arrest Notes - 19-A00355

On Thursday, 02/07/2019 at approximately 4:13 pm, I Officer T. Roper (287) responded to 600 N. 7th St (Woodridge) in reference to a juvenile complaint. Upon arrival, I made contact with the complainant/victim (Stevens) who advised the arrestee [REDACTED] battered her. Stevens advised her and the witnesses (Dent and Hooper) attempted to move [REDACTED] to another room after a previous altercation she had with another child in the facility. While moving her, [REDACTED] became combative causing injuries and swelling to Stevens left hand. Stevens also spat blood onto the face of Dent and Hooper.

I observed the injuries to Stevens hand to be red and swollen. I collected photos of the injuries and also collected written statements from the victim and witnesses.

[REDACTED] was arrested, charged with the listed offense, and transported to the Crittenden County Juvenile Detention Center.

Juvenile Officer S. Moore advised to hold [REDACTED] until further notice.
