Narrative - Middlebrook, Jeffrey - 2/13/2019 (Initial)

On February 13, 2019 at approximately 7:13 PM, I, J. Middlebrook #256 was dispatched to 600 north 7th Street (Woodridge) in reference to a suspicious person complaint.

Narrative - Middlebrook, Jeffrey - 2/13/2019 (Initial)

Upon arrival, I made contact with the caller in reference to the suspicious person. She advised a black male wearing a grey hoodie and blue jeans came to her vehicle from the side walk. She advised the suspicious black male tried to open the car door, and then left the property.

Upon checking the parking lot at approximately 7:30 PM for the male, I observed a red Dodge Challenger in the parking lot where the employee's park with both the drivers and passenger doors slightly opened. I also observed the truck slightly opened as well. I then made contact with vehicle owner (victim) Rene Brimingham inside the business and advised her of the discovery.

Brimingham walked with me to the location of her vehicle in the parking lot. Once Brimingham reached her vehicle she and I observed the contents of her vehicle lying all over the interior of the vehicle. I observed the glove box opened and all the contents strewn about the interior of the vehicle.

Brimingham stated that she arrived at work at approximately 5:35 PM and she went inside the building and left the key fob to the vehicle in the center console of the vehicle. Brimingham stated that her vehicle is a push to start style vehicle. Brimingham stated a green unknown brand purse was also stolen from the vehicle, but the contents were dumped in the front seat of the vehicle.

While looking in the immediate area, I discovered an unknown brand green purse lying in the weeds behind an employee smoking building. I asked Brimingham if the purse was her, and she stated it was. Brimingham stated that the only thing stolen from her vehicle was the key fob for the vehicle and her Arkansas driver's license.

Brimingham stated that her husband is coming to get the vehicle and take it to their residence. Brimingham stated that there are security cameras at the facility, but she is unsure if any of them point to the parking lot area.

A written statement is attached to this report.
