On February 15, 2019, I, Officer Toney was dispatched to the station for a battery 3rd report that took place February 11, 2019. Upon arrival, I contacted Timothy Blackmon who stated that he had been assaulted at Woodridge Behavior Center located at 1521 Albert St. Mr. Blackmon came to the station to do a sworn affidavit and it goes as follows:

At this date; 2/11/2019 at time 1851, I was assisting with a resident at Woodridge Behavioral Care in Forrest City. The resident [REDACTED] was non-compliant to directions at the time listed above. Myself, nurse, and floor lead were trying to process this resident, but he continued to be defiant and showing increased aggression towards staff. Upon assisting and redirecting, [REDACTED] became physically aggressive with me grabbing and twisting my upper left arm. The grabbing caused minor bruising and I sustained a busted blood vessel. I was ordered to the hospital on 2/14/19 for further testing.
