OFFICERS WERE DISPATCHED TO THE LISTED LOCATION, FOR A RUNAWAY JUVENILE REPORT. OFFICERS MADE CONTACT WITH MS. TINA LITTLETON, WHO IS THE BEHAVIOR INSTRUCTOR AT METHODIST CHILDREN HOME. MS. LITTLETON SAID SHE WAS AT CLINTON CHILDREN LIBRARY, LOCATED AT 4800 WEST 10TH STREET, WHEN JUV-1 RAN OFF. ACCORDING TO MRS. LITTLETON JUV-1 HAD A VERBAL ALTERCATION WITH ANOTHER PERSON JUVENILE. JUV-1 TOLD THE STAFF HE DID NOT WANT TO RIDE IN THE VAN WITH JUV-2. MS. LITTLETON TOLD JUV-1 SHE WOULD FIND OTHER MEANS OF TRANSPORTATION BUT JUV-1 FLED. MS. LITTLETON SAID SHE SAW THE JUVENILE WALKING EAST ON 10TH STREET AND SHE WAS UNABLE TO CATCH UP TO HIM. OFFICERS COMPLETED A BROADCAST AND CIRCULATED THE AREA, WITH NEGATIVE RESULTS.

AT APPROXIMATELY 1748 HOURS, OFFICERS WERE ADVISED JUV-1 HAD RETURNED TO THE HOME. OFFICERS WENT BACK TO THE LOCATION, WHERE OFFICERS VERIFIED THE JUV-1 WAS THERE AND APPEARED TO BE SAFE. MVR IN USE
