Upon arrival, I made contact with Julia Branch. Branch stated that arrestee Astrid Stidum, threw furniture around the room and was destroying the facility. I observed that the chairs in the lobby were upside down along with clothing thrown on the floor. Victim Faadiyah Tramble, advised that [REDACTED] started getting aggressive when another patient ([REDACTED]) began getting loud with the staff. Tramble stated [REDACTED] then got in the face of a therapist and began threatening to kill her. Tramble then stated [REDACTED] attempted to strike her with a closed fist. Tramble advised she tried restraining [REDACTED] however [REDACTED] was able to kick her in the back. [REDACTED] then threatened to

kill some of the staff. At this time, I placed [REDACTED] into custody for Battery 2nd degree and Terroristic threatening. Contact was made with Juvenile Officer Brookin who advised to hold both subjects until further notice.

I observed a small laceration on the lip of Branch. Photographs were taken of her injuries and attached to the report.
