**Narrative - Jones, Joe - 3/29/2019 3:15:00 PM (Initial)**

On March 29, 2019 at approximately 1515 hours, I (Officer Jones) was dispatched to Mill Creek in reference three male subjects that had escaped from the property.

Upon arrival I made contact with a worker, who advised that they had caught one but the other were still on the loose. I was advised the male that was caught was in the area of the rail road tracks at the old Kingsland Highway.

I then went to the area in attempt to locate the subjects. Mill Creek workers advised me that one subject was white and the other was black and the white male was wearing a blue shirt and other male was wearing a black shirt.
