OFFICERS WERE DISPATCHED TO THE LISTED LOCATION FOR A "RUNAWAY JUVENILE". OFFICERS MADE CONTACT WITH THE COMPLAINANT, MELDIN WALKER, WHO ADVISED JUV#1 HAD RAN AWAY EARLIER TODAY. MR. WALKER STATED THEY HAD REPORTED HIM MISSING EARLIER BUT HE HAD COME BACK, YET THEY DID NOT REPORT HE HAD RETURNED AND TOOK SOME FOOD THEN RAN AWAY AGAIN. MR. WALKER STATED HE LAST SAW JUV#1 RUNNING SOUTHBOUND ON FILLMORE AND WANTED OFFICERS TO GO TAKE A LOOK FOR HIM. MR. WALKER DID NOT WANT A THEFT REPORT FOR THE FOOD JUV#1 HAD TAKEN BUT WANTED AN INFORMATION REPORT. OFFICERS CIRCULATED THE LOCATION WITH NEGATIVE RESULTS OF JUV#1. IT WAS DISCOVERED THAT THERE WAS NO INITIAL REPORT OF THE MISSING JUVENILE AND THE JUVENILE HAS BEEN RECOVERED. MVR IN USE.
