On 4/19/2019 at approximately 4:00PM, I Officer M. Gill #244 was dispatched to 600 North 7th street in reference to a Battery complainant.

I arrived on scene and made contact with a staff member who escorted me to the suspect. As I entered the room, I observed several staff members restraining the listed arrestee on the floor. I approached the female and advised her to place her hands behind her back and she complied. I identified the arrestee as Ally Niebrugge by her Illinois identification card. I asked Niebrugge what the issue was and she stated, "these fucking idiots". Niebrugge would not elaborate on the situation any more. I then made contact with the victim, identified as Angela Clayton, who stated she was in a sit down meeting with Niebrugge about an incident which took place on 4/18/2019. Clayton stated during the meeting, Niebrugge became angry and picked up a chair and threw it at her. Clayton stated she was able to put her hands in front of her head and blocked it from striking her face. Clayton stated she did not have any marks or bruises

on her arm that were visible at this time. I then placed Niebrugge into custody for Battery 2nd degree. Niebrugge was transported to the Crittenden County Detention Facility. Niebrugge was advised of her court date and time.
