Narrative - Jones, Joe - 4/21/2019 11:44:00 PM (Initial)

On April 21, 2019 at 2254 hours I (Officer Jones) was dispatched to Millcreek in reference to two subjects they had escaped from the facility. Upon arrival I made contact with Nurse Laura Lindsey, who stated two subjects had ran away and they had been gone about 45 minutes.

Mrs. Lindsey stated the names of the subjects were [REDACTED] and [REDACTED]. Mrs. Lindsey stated [REDACTED] was wearing a camo jacket and gray sweat pants and [REDACTED] was wearing red hoodie with Hustler written on it with gray sweat pants.

I attempted to locate the subjects but were unable to locate them. They were entered into ACIC database.
