NARRATIVE

OFFICERS MADE CONTACT WITH MR. WALKER A STAFF MEMBER AT METHODIST CHILDRENS HOME. ACCORDING TO MR. WALKER JUV#1 BECAME UPSET BECAUSE SHE COULD NOT HAVE HER TELEPHONE AND HER LIBERTY PASS WAS REVOKED. MR. WALKER STATED JUV#1 BEGAN THROWING DISHES, BREAKING LEGS OFF THE DINNER TABLES, AND TEARING BULLETIN BOARDS OFF THE WALL.
