Narrative - Crutchfield, David - 5/7/2019 (Initial)

On 5/6/2019, was in therapist's (Misty Winters) office for an intake evaluation. At the end of the intake, as told that she would not be leaving the building. She got up out the chair, and began punching the window in the office. She was damaging the window blinds. Misty Winters attempted to place in ESI "Emergency Safety Intervention. She ran in to the door, which was closed. Her Mother yelled, "Don't let her out, she will run!" Winters opened the door, and attempted to placed in an ESI against the wall in the hall. got loose from Winters, and began to punching Winters in the head several times. Other staff (Program Manager Karen Walker and Nurse Manager Bernetta Lowe) assisted with the ESI.
