NARRATIVE

OFFICERS RESPONDED TO THE METHODIST CHILDREN'S HOME LOCATED AT 2002 SOUTH FILLMORE IN REFERENCE TO AN OUT OF CONTROL CHILD. THE CALLER STATED THE CHILD WAS BREAKING THE WINDOWS IN AN ATTEMPT TO GAIN ENTRY INTO ONE OF THE BUILDINGS. CONTACT WAS MADE WITH JACOBIE AMOS, A BEHAVIOR COUNSELOR AT THE HOME. MR. AMOS STATED WAS UPSET ABOUT BEING KICKED OUT OF HIS GROUP AND WAS BREAKING THE WINDOWS TO HIS GROUP HOUSE. WHEN OFFICERS ARRIVED ON SCENE, WAS STANDING AT THE REAR OF THE HOUSE CRYING STATING HE HATED IT AT THE METHODIST CHILDREN'S HOME. HAD A SMALL LACERATION ON HIS LEFT THUMB AND AN APPROXIMATELY 2-3 INCH LACERATION ON HIS RIGHT PALM. MEMS WAS NOTIFIED AND RESPONDED TO THE SCENE. MEMS CLEANED HAND AND BANDAGED IT. THEY ADVISED THE LACERATION WAS NOT DEEP AND WOULD NOT REQUIRE STITCHES. THE COUNSELORS AT METHODIST CHILDREN'S HOME TRANSPORTED TO MAMELUKE AND ADMITTED HIM INTO BRIDGEWAY. THE DVR IN VEHICLE 16C367 WAS IN USE.
