Narrative & Statements

Narrative - Jordan, Jennifer - 10/1/2019 (Initial)

On 10-01-2019 I Sgt. Jordan made contact with the complainant at 626 E. Broadway in reference to her needing to file a report. Upon speaking to her she advised that her daughter [REDACTED] disclosed that she has seen the suspect "Mr. Thomas" penis. Mr. Thomas was an employee at Perimeter Behavioral . It is believed that there was possible physical contact with the victim and the suspect. According to the complainant she was informed that [REDACTED] was named as a possible victim in a sexual assault allegation by another resident at the facility. Mr. Thomas has since been terminated from the facility for unrelated matters. The victim is currently still located at the facility.
Ms. Ross advised that she wished to prosecute.

Narrative - Dixon, Lauryn - 10/22/2019 (Investigative)

The victim was interviewed at the CAC where she disclosed that she performed oral sex on the alleged suspect. The suspect at the time of this incident was a worker that was in a position of power at the behavioral facility.

10/28/2019- I met with DPA who advised at this time he does not want to file on this case.
