On 8-4-19 I Officer Adrian Todd, was dispatched to Woodridge in reference, to the residents hitting staff and trying to escape. Upon arrival, I observed [REDACTED] and [REDACTED] being defiant. Both began stating to coworkers "Fuck the police and they ain't shit". As we were trying to calm the situation down they began looking us up and down, they were asked to go to their room they stated they would not. [REDACTED] even stated to a trooper "fuck you", [REDACTED] and [REDACTED] was placed into custody for inciting a riot. While speaking to the staff we were advised that they could not get the residents to calm down because of [REDACTED] and [REDACTED] and that the staff were scared of them. I was also advised from Ms. Washington, Ms. adkins that they were both threatened by [REDACTED] and [REDACTED] Ms. Turner stated that while she was assisting to help restrain [REDACTED] she bent her finger.
