## Arrest Notes - 19-A03305

On 09/30/2019 i ( Officer Davis) made contact with the arrestee at 1550 Ingram in reference to prior knowledge of him having a warrant. An NCIC/ ACIC search confirmed that he had an active warrant for his arrest for Sexual Assault 2nd signed by the Honorable Judge Fred Thorne on the 25th day of September 2019. ( WM-19-1968) Bass was taken into custody and transported to the County Jail where he was advised of his court date and time.

## Narrative - Kimbrough, Amber - 8/23/2019 (Initial)

On August 23, 2019 Betty Stahl came to CID to file a report for sexual assault against her daughter, [REDACTED] while being a resident at Perimeter Behavioral Hospital. I received a child abuse hotline report on August 15 stating that [REDACTED] was asked to come to the laundry room on the 12th by a worker named Mario. Once in the laundry room Mario handed her a piece of paper and told her to read it to which [REDACTED] replied that she didn't have her glasses and couldn't see it. Mario told her to get her glasses so she did and the paper read "I want to see your slim body". [REDACTED] left out of the laundry room and there was no contact made at this time. Later that evening [REDACTED] asked her roommate to try and stay up with her because of Mario but she fell asleep. Mario entered into her room and took her glasses and left out. Mario came into the room approximately 3-4 times attempting to wake [REDACTED] up. The last time that Mario came into the room he rubbed on [REDACTED] butt and tried to roll her over to touch on her breasts. All of the touched was over the clothing.

Stahl advised that [REDACTED] reported the first incident to nurse Janna. The next day [REDACTED] n reported the second incident to nurse Linda.

A forensic interview has been conducted with [REDACTED] by Sherrice Vales with CAC and Sarah Cooper with CAC on August 15th.

## Narrative - Kimbrough, Amber - 8/30/2019 (Investigative)

August 30, 2019- I went to Woodridge and got their video footage from the incident which did show the suspect enter the room of the victim, there are no cameras inside the room. They also provided me with the suspect information and advised that he had been terminated.

## Narrative - Dixon, Lauryn - 9/23/2019 (Investigative)

I made contact with Sherrice Vales with Arkansas Crimes Against Children Division. She advised that she made contact with witness ([REDACTED]) who stated that she observed the suspect give the victim a note telling her to get naked so he can see her. She then observed later on that night the suspect come into their room and touch her on her breast and butt. She stated this is the only incident she is aware of and did not know if the suspect had done this to any other females in the facility at the time. She did state that the suspect told her not to tell anyone what he did.
