Narrative & Statements

Narrative - MCGINNIS, Jeffery A - 9/5/2019 (Initial)

On the above date I had walk up complaint about assault that happened at the Dacus Residential treatment facility, when I arrived I spoke with Thomas Baily and Shana Beck and they told me they had been assaulted by the above named juvenile.

Baily said that he was working the hall way when the juvenile jumped in a cloths ben and he told him to stop the juvenile continued to act out and then punched him in the head as he was trying to control him (see attached statement from Baily), I was unable to see any marks or bruising on Baily.

I then ask Beck what happen and she said the juvenile would not follow instructions and started yelling and punching Baily and she got in between them and then they put him in a room when nurse open the door and that's when she got hit (see Beck attached statement), I did see a small red scratch on Beck arm and she said that happened when they pushed the juvenile in the room.

I contacted Juvenile Officer Tatty Rossman and advised her that the employees wanted to follow through with

charges and I advised her all I could charge him with is Battery 3 at this time. I went to where they had the juvenile in the room and he was calm and was no trouble I placed him under arrest and transported him to the juvenile detention Center and given a court date of September 25th at 8:30 a.m.

Dacus Facility said they were contacting the juveniles parents that's all I have at this time.
