On 9-16-19 at approximately 8:41 pm I Officer Mansel was dispatched to WoodRidge for a runaway juvenile. Upon arrival contact was made with the reporting party staff member Laveta Johnson. Ms. Johnson identified the runaway as [REDACTED] white male 16 years old, [REDACTED] Last seen wearing a red shirt and blue jeans. Ms. Johnson stated that [REDACTED] has short black hair, 5'7", 138 pounds. [REDACTED] got out of the facility and ran east on Lindauer Rd. towards the UPS building. The area around WoodRidge was checked but Officers were unable to locate the juvenile.

At approximately 9:47 pm dispatch was on the phone with Ms. Johnson trying to get more information. While speaking with Ms. Johnson [REDACTED] came back to the facility and staff was able to get him back in the building.
