Friday, October 18, 2019 at 11:25AM, Lt. Eric McCoy, Sgt. Jonathan Fought and I, Ptl. Gloria Aldridge, were dispatched to Woodridge Behavioral Care, located at 1521 Albert St. Upon arrival, we spoke with Mr. Andre Mills, The Youth Care Lead and his co-worker, Mr. Jacserri Jackson, A Youth Care Worker. reported that they want to file assault charges against one of the juvenile residents, 16 year old Mr. Jackson stated that fence this morning and he had to chase him. He stated that when he cought he took him back to the facility and to be held down until he calmed down. He stated that 3 of them had to take turns holding him because kept fighting them and they were tired. Mr. Jackson reported that he received an injury to his left forearm. He stated that there are no visible injuries but there is pain. Mr. Mills also stated that he was injured during the incident.
