On 11-3-19 at approximately 9:22am I Officer Mansel was dispatched to Woodridge behavioral center for juveniles for a battery report. Upon arrival I made contact with the two staff members that were assaulted by the juvenile resident who they identified as [REDACTED] who stays of the (SRU) sexual rehabilitation unit ward. Teairra Howard stated that [REDACTED] and his room mate were throwing shoes against the wall and doing negative horse playing. Ms. Howard and Ms Foster the other staff member involved went to take the residence belongings out of the room and that is when [REDACTED] got in there face and said dont touch my fucking shit. [REDACTED] the left the room for a few minutes and walked down the hall. Ms. Howard stated that when [REDACTED] came back he started punching and he hit here in the left side of her jaw. Ms. Foster was also hit several times. Ms. Howard and Ms Foster got out of the room and called for male staff to detain [REDACTED] When the male staff arrived they had to put [REDACTED] on the ground and hold him to get him to stop punching. The police were notified and [REDACTED] was taken in to custody and transported to the station to be held. [REDACTED] was later released and taken back to WoodRidge and turned over to Ms. Howard. Ms. Howard also signed the juvenile intake papers. [REDACTED] has an intake date for 11-6-19 at 830am.
