NARRATIVE

ON 01/07/2020, WE RESPONDED TO 6601 WEST 12TH STREET, CENTERS FOR YOUTH AND FAMILY, FOR AN ASSAULT REPORT. UPON OUR ARRIVAL, WE MADE CONTACT WITH MS. ADAMS, A TEACHER AT THIS FACILITY. MS. ADAMS STATED HER STUDENT, JUVENILE #1, WAS IN HER CLASS AND BECAME UPSET ABOUT MS. ADAMS TELLING HIM HE COULD NOT USE A COMPUTER. JUVENILE #1 THREW A BOOK AND A CHAIR IN HER DIRECTION. JUVENILE #1 HAS EXTREME BEHAVIORAL ISSUES AND HAS BEEN IN THIS FACILITY SINCE 2018. JUVENILE #1 CONTINUED TO CAUSE A RUCKUS IN THE CLASSROOM. MS, ADAMS SAID SHE VERBALLY TOLD HIM TO STOP BUT HE CONTINUED. OTHER STAFF CAME IN AND ATTEMPTED TO PLACE HIM IN A RESTRAINT. MS. ADAMS SAID SHE WENT TO ASSIST AND JUVENILE #1 PUNCHED HER IN THE FACE AND SLAPPED HER AS WELL. I DID NOT OBSERVE ANY MARKS ON MS. ADAMS AND SHE REFUSED MEDICAL ATTENTION. MS. ADAMS SAID HE HIT HER INTENTIONALLY. DET. TEMPLE WAS NOTIFIED ALONG WITH JUVENILE INTAKE. DUE TO THE AGE OF JUVENILE #1, 9 YEARS OLD, HE WAS NOT CHARGED. MS. ADAMS WAS GIVEN A COPY OF THE REPORT NUMBER. NO FURTHER POLICE ACTION COULD BE TAKEN. MVR IN USE.
