NARRATIVE

OFFICERS WERE DISPATCHED TO AN ASSAULT REPORT AT THE LISTED LOCATION. UPON ARRIVAL, OFFICERS MADE CONTACT WITH MS. LETOYIA BEARDEN WHO STATED SHE'S AN EMPLOYEE (TECH) AT THE LISTED LOCATION. MS. BEARDEN ADVISED TWO JUVENILES WERE PHYSICALLY ASSAULTING EACH OTHER IN A BREAK ROOM, SHE ADVISED WHEN SHE SEEN THE JUVENILES FIGHTING, SHE WENT IN BETWEEN BOTH OF THEM AND ATTEMPTED TO SEPARATE THEM. SHE STATED WHEN SHE GRABBED JUVENILE 1 TO GET HER AWAY FROM THE OTHER JUVENILE, JUVENILE 1 STARTED ATTEMPTING TO HIT HER AND ENDED UP SCRATCHING MS. BEARDEN IN THE FACE. OFFICERS WERE ABLE TO OBSERVE A FEW MINOR SCRATCHES IN MS. BEARDEN FACE. MS. BEARDEN REFUSED MEDICAL AT THE SCENE. OFFICERS MADE CONTACT WITH JUVENILE 1, WHO STATED SHE WAS FIGHTING WITH ANOTHER JUVENILE. JUVENILE 1 STATED MS. BEARDEN WENT IN BETWEEN BOTH JUVENILES AND IN THE PROCESS OF MS. BEARDEN BEING IN THE MIDDLE, JUVENILE 1 STATED SHE WAS IRATE AND SCRATCHED MS. BEARDEN IN THE FACE. NORTHWEST SUPERVISOR WAS NOTIFIED OF THE INCIDENT. OFFICERS ADVISED MS. BEARDEN TO SEEK WARRANTS FOR BATTERY 3RD. NO FURTHER POLICE ACTION WAS TAKEN. MVR IN USE.
