On February 17, 2020 at approximately 2:15 pm, I, Officer Shane Andrews arrived at the station in reference to a report. Upon my arrival, I made contact with Ms. Lillian Suggs. Ms. Suggs stated that on Thursday February 13, 2020, she was teaching a class at Woodridge perimeter health care. While she was in her class, a student [REDACTED] kept walking passed her. Every time he would come past he would get real close to her and brush against indecent parts of her body. She told him to stop and the he then began to pretend he was falling against her and touch her in places. The final time he walked past, [REDACTED] took some lotion and squirted it on her butt and stated "I just nuted on that ass". Ms. Suggs stated he then began to rub himself in the groin area and began making very vulgar moaning sounds. Ms. Suggs stated she went to the office to file the paper work and they advised her to come press charges. Ms. Suggs stated that Lanora Bolden and some other staff was in the room at the time this took place. We have had several complaints and several charges filed on [REDACTED] in the past few weeks, and we have responded to several calls in reference to him assaulting staff members.
