Ms. Akua Wren and Ms. Lillie Suggs came to the FCPD to complete affidavits, which have both been completed at the time of completion of this report, on the stated that was playing with his genital area and interupting class with indecent sexual outbursts like, "I'm going to show you my pussy," whilst having his hands in his pants. Ms. Suggs stated that pulled his genitals out enough to where she could see the hairy section of his private areas. Ms. Suggs also stated that when it was time for lunch, got up and grabbed her keys, throwing them, and hitting her in the chest with the keys.
