On 02/28/2020, the Forrest City Police Department was contacted regarding a subject located at 603 Kittle Rd, Woodridge. Ms. Akua Wren and Ms. Lillie Suggs came to the FCPD to complete affidavits, which have both been completed at the time of completion of this report, on [REDACTED]. In Ms. Suggs classroom, she stated that [REDACTED] was playing with his genital area and interrupting class with indecent sexual outbursts like, "I'm going to show you my pussy," whilst having his hands in his pants. Ms. Suggs stated that [REDACTED] pulled his genitals out enough to where she could see the hairy section of his private areas. Ms. Suggs also stated that when it was time for lunch, [REDACTED] got up and grabbed her keys, throwing them, and hitting her in the chest with the keys.

Ms. Wren stated that she dealt with [REDACTED] right after Ms. Suggs class and she stated that she was coming down the hallway, towards Ms. Suggs classroom, when [REDACTED] pushed up against her, rubbing against her breast intentionally.

Both instances occurring less than 5 minutes apart, and both Ms. Wren and Ms. Suggs stated that he continued this lewd activity before they left and that he was inappropriately touching on other female staff members. Ms. Suggs stated that these occurrences were on camera and that footage has been put on a flash drive. Said flash drive needs to be recovered for evidence.
