On Saturday, March 21, 2020 FCPD officers were dispatched to Woodridge in reference to a large fight in progress. Upon arrival, the fight had been broken up by staff. Officers then made contact with the nurse, Mary McCullough, and Youth Care Worker Latoria Hull. Mrs. McCullough stated that there was a fight in the day room 2.4. As she was attempted to calm down [REDACTED], she was grabbed by the right arm and pushed against the wall by [REDACTED].

Ms. Hull stated that she also heard the disturbance. At that time, she noticed that [REDACTED] had left his assigned area. While attempting to get [REDACTED] to return to his assigned area [REDACTED] came jumped over top [REDACTED] and began to talk to him. She told [REDACTED] to return to his area and at that time [REDACTED] began striking [REDACTED] in the with a closed fist. That's when [REDACTED] and [REDACTED] jumped into the fight. While attempting to break up the fight she stated she was elbowed in the face by [REDACTED] and [REDACTED] struck her in the right side.
