NARRATIVE

OFFICERS RECEIVED A CALL TO THE LISTED LOCATION IN REFERENCE TO A JUVENILE PATIENT ASSAULTING ONE OF THE EMPLOYEES. OFFICERS MADE CONTACT WITH THE EMPLOYEE, AUSTIN. HE ADVISED JUV 1 PUNCHED HIM IN THE FACE AND PUSHED HIM, CAUSING HIM TO FALL AND TWIST/ROLL HIS ANKLE. AUSTIN STATED HIS ANKLE WAS IN "EXCRUCIATING" PAIN, BUT REFUSED MEDICAL ON SCENE. OFFICERS OBSERVED AUSTIN'S ANKLE TO APPEAR TO BE SWELLING. AUSTIN STATED JUV 1 WAS ATTEMPTING TO SLAM A DOOR IN ANOTHER JUV'S FACE, AND AUSTIN ATTEMPTED TO INTERVENE, AT WHICH POINT JUV 1 BEGAN PUNCHING AUSTIN IN THE FACE SEVERAL TIMES.
