On 4-5-20 at approximately 1:07pm Officers were dispatched to 603 Kittle Rd Woodridge behavioral facility for a disturbance between several juveniles and staff members. Upon arrival contact was made with one of the complainants head nurse Mary McCullough who stated that three of her staff members had been assaulted by three of the juveniles.

Staff member Levester Butler stated that juvenile [REDACTED] and juvenile [REDACTED] where in an altercation. Mr. Butler stated that he was holding resident [REDACTED] to prevent physical aggression and that is when resident [REDACTED] punched [REDACTED] in the stomach and the head.

Staff member Lenora Bolden stated that two residence [REDACTED] and [REDACTED] both assaulted her during the altercation. [REDACTED] aggressively pushed her away and [REDACTED] twisted her left forearm that caused her to seek medical attention from EMS at the scene.

Staff member Teairra Howard stated that she was called to Station 2 for staff support due to physical aggression of the residence on hall 400 towards staff and other residence. When Ms. Howard arrived staff was removing a resident from the hallway when several other residenfs ([REDACTED])

[REDACTED] rushed the hall. Ms. Howard was attempting to hold the residents back from attacking resident [REDACTED] [REDACTED] physically pushed Ms. Howard off of him and into the wall.

Affidavits have been filed by staff on four of the juveniles for battery 3rd degree. A court date is pending in this case. All juveniles were served on site and released back to the staff.
