PR1 SHOWED VIDEO FOOTAGE TO OFFICERS OF S1 STANDING IN A CORNER AT THE CENTER FOR YOUTH WITH A PENCIL. PR1 ADVISED S1 HAS SUICIDAL TENDENCIES AND IS NOT ALLOWED TO BE IN POSSESSION OF SHARP OBJECTS. THE FOOTAGE SHOWS V1 NOTICING S1 HAS THE PENCIL AND WALKING UP TO S1. V1 THEN TAKES THE PENCIL FROM S1 AND S1 BECOMES COMBATIVE. S1 IS SEEN STRIKING V1 IN THE GROIN APPROXIMATELY THREE TIMES. V1 WAS ABLE TO SUBDUE S1 AND GET HER CALMED DOWN. PR1 ADVISED SHE WAS HAVING S1 SENT TO BRIDGEWAY. PR1 ADVISED SHE CALLED POLICE TO HAVE A REPORT MADE BUT DID NOT INTEND TO SEEK WARRANTS.
