## Narrative

On April 10, 2020, at approximately 0951 hours, I responded to 161 Skunk Hollow Road in reference to a disturbance. Dispatch advised they received a call from Ms. Candi Sibley (complainant/victim/director of nursing with Little Creek Behavioral Health), who stated a 14 year old female had barricaded herself in her room and was acting destructive. She stated the female, JO1 (offender), has been physical with others in the past week and was threatening her and other staff members.

Upon arrival, I made contact with Ms. Lisa Wood, a nurse with Little Creek Behavioral, who stated JO1 became upset and began threatening Ms. Sibley and several other staff members. She stated JO1 stated multiple times while yelling and cursing she was going to "kill them". Ms. Wood stated JO1 has been "instigating" other patients in the facility for the past week. She stated JO1 had been throwing items around and grabbing at the staff. She stated JO1 had become extremely unsafe to stay at the facility due to concern she would harm other patients or staff members. Dispatch was unable to locate any information for Ms. Wood in ACIC at the time of report.

I made contact with Ms. Katie Winston (others involved/staff member), who stated JO1 had closed her bedroom door and barricaded herself. She stated when the staff had opened JO1's door she became upset and stated "I will kill you."

I made contact with Ms. Sibley who stated she entered the nursing staff area after hearing yelling while she had been in her office. She stated when she entered JO1 had barricaded herself in her room. Once the staff had been able to make entry into her room, JO1 ran out and started climbing on the furniture. She stated she asked JO1 to exit her room and JO1 started yelling her and other staff members. She stated JO1 walked up to her and stated "I will kill you" multiple times. She stated JO1 attempted to place a comb into an electric outlet and a staff member was able to prevent her from doing so. She stated JO1 continued to scream "I will kill you" until I arrived on scene.

I made contact with JO1 who stated she became upset with several staff members. She stated she told several of the staff members "I will kill you".

I made contact with Cpl Tillman (others involved) and advised him of the incident. I made contact with Juvenile Intake and advised them I would have terroristic threatening 2nd degree charges on JO1. Juvenile Intake advised JO1 qualified through the points system but would need to contact a supervisor in Juvenile Detention and verify they would accept due to the Covid-19. Juvenile Intake advised after speaking to a supervisor they would not accept JO1 due to she was pre-diabetic. They advised Little Creek Behavioral would need to

contact JO1's case worker due to her being in the custody of the State of Ohio. They advised JO1 would need to be seen at Conway Behavioral Health Unit. Ms. Sibley advised she would contact the Director and attempt to get placement at the facility for JO1. I advised her if she needed assistance on transporting JO1 to the facility she could contact MEMS. I advised her if she needed further assistance to contact the sheriff's department. While on scene, JO1 had calmed down and stated she did not have intentions to harm anyone she was just upset. I advised Ms. Sibley of this report number and how to obtain a copy.
