On Monday May 11, 2020 at approximately 0929 hours, I was dispatched to 2466 S. 48th St. (Perimeter of the Ozarks) for a Harassment call.

While en route I was advised that the caller Jennifer Anderson (W/F Dob 7-25-77) had called on behalf of her [REDACTED] Ms. Anderson stated that [REDACTED] had a No Contact Order out of Sabastian Co. against [REDACTED] grandfather Carroll Little (W/M Dob 12-15-50) but that he had been sending [REDACTED] letters and packages to [REDACTED] while [REDACTED] was residing at Perimeter.

I was later able to look up Mr. Little and discovered that there is no active no contact order against him.

Upon arrival I was able to make contact with [REDACTED] case worker Ashley who advised that there had indeed been at least one letter that had been delivered to the facility within the last week that had been addressed from both Mr. Little and his wife.

The caseworker Ashley said that they have a screening process for the mail and only items that are from preapproved individuals dictated by the parents are allowed to be delivered to the [REDACTED] Ashley said that the grandparents were not on that list and when they called Ms. Anderson to ask about the letter she informed them that it was not ok to deliver the letter to [REDACTED] and they advise her that they were holding it until Ms. Anderson arrived to pick up [REDACTED] next week.

I asked Ashley if [REDACTED] had any knowledge of the letter or any other forms of communications and she said that [REDACTED] had no idea of anything.

I then made contact with Ms. Anderson via phone call and advised her of what I discovered and she advised that she wanted to press charges for the incident. Ms. Anderson advised that [REDACTED] birth parents had passed away and that they had adopted [REDACTED] and that Mr. Little was [REDACTED] biological grandfather on [REDACTED]

Looking up Mr. Little through ACIC I discovered that back in 2015 he was charged with sexual assault 2nd of [REDACTED]

Due to not being able to locate a valid no contact order I informed Ms. Anderson that I would file a report for harassing communications and gave provided her with her options in moving forward.
