**Narrative**

On Thursday, June 18, 2020, I was dispatched a sexual offense call for service. I made contact with Ms. Suzie Roberts (complainant) via phone at her request. Ms. Roberts works for the ASP Crimes Against Children.

Ms. Roberts stated that it was reported to the hotline that a sexual offense occurred at 161 Skunk Hollow Rd (Little Creek Behavioral Health) between a patient and a staff member.

It was reported that JV1 (victim) made a report to staff that she was touched inappropriately by Mr. Reshawn (offender). It was reported that Mr. Reshawn rubbed her vagina.

JV1 is in DHS Custody out of Ohio and has been placed at Little Creek Behavioral Health for treatment. This was reported to have happened on June 6, 2020.

I gave Ms. Roberts the report number and advised her how to obtain a copy. Not enough information was provided to the hotline to locate the offender in ACIC/NCIC or JV1.
