Narrative

On Thursday, June 25, 2020, at approximately 13:23 hours, I responded to 161 Skunk Hollow Road for a medical call. Dispatch advised a staff member, victim at the Little Creek Behavioral Health treatment facility, at that address, had been kicked in the head and was having difficulty breathing.

Deputy Graham arrived just before I did. As I was pulling into the parking lot, I was advised one or more juveniles may have fled the facility. An unknown staff member directed me across the west lawn, toward Skunk Hollow Road for a juvenile. I saw a female, (others included, J2) with red hair and a bright pink shirt walking toward Skunk Hollow Road. I ran after her and caught up with her approximately 100 feet west of Skunk Hollow Road. J2 was barefooted. I assisted her back to the facility and walked her inside.

While I was pursuing J2, I heard Deputy Graham and Dispatch advise, over the radio, the juveniles were rioting. After escorting J2 to the dining room, in the facility. Deputies Graham and Vaughan were with a few juveniles unnamed in this incident.

Also in the room was Juvenile offender, (J1). J1 was sitting calmly at a dining room table with an unnamed person, who appeared to be a staff member. I heard Staff members of the facility advise another disturbance in the facility. I responded to assist there, in another part of the facility.

I heard via radio, victim, (later identified as Edward Hester, was transported to Conway Baptist Hospital. The extent of Mr. Hester's injuries was unknown at the time of report. I heard, over the radio, that five juveniles were missing and were suspected to have left the facility. I advised Dispatch to call out the Faulkner County Emergency Squad. I asked staff for clothing descriptions and photographs of the missing juveniles. Before I received descriptions and photographs, I heard over the radio all juveniles were accounted for and none were missing.

Juvenile Intake Officer, Franklin, agreed to take J1 into Juvenile Holding. I cited J1 with C219416 for 5-13-203, Battery 3rd degree. I transported J1 to Faulkner County Juvenile Detention Center. En route, J1 asked about Mr. Hester's condition. He told me he did not mean to hurt Mr. Hester. He said he had tried to fight other juveniles for things they were doing to him. He was grabbed and kicked backwards against the person, (Mr. Hester), but was trying to get away.

Booking personnel took custody of J1. My body-worn camera was operating during this incident. However, it appeared to be malfunctioning. It was unknown, at time of report, whether the recording may be able to document my actions.
