## Narrative

On 06/29/2020, at approximately 1423 Hours, I was dispatched to Little Creek Behavioral Health for a suicide attempt, with the individual being unresponsive.

Upon arrival, Deputy R. Coors (FTO) and I (Deputy M. Baker) were escorted to JV1 (victim) by staff. JV1 was being observed by the staff of Little Creek Behavioral Health (complainant), while awaiting MEMS.

I spoke with Mr. Jeffery Tyus (others involved), who stated he found JV1 lying in the shower floor, with clothing wrapped around their neck. Mr. Tyus told me that JV1 was unresponsive, but breathing at the time he found her. Mr. Tyus stated he removed the clothing from JV1's neck and JV1 then began to regain consciousness. We were advised that JV1 has a history of suicide attempts. While on scene, JV1 was alert and able to move by her own power.

MEMS transported JV1 to Baptist Hospital with staff following for further observation.
