On July 13th, 2020, I, Ofc. D. Dowdy, was dispatched to Woodridge in regards to two runaway juveniles.

I was dispatched at 0842. Upon my arrival, Amy Brumley, LPN, advised that the workers who saw the children jump the fence stated it occurred at approximately 0830.

Ms. Brumley stated that the juveniles jumped the fence at the rear right corner of the building, if you're facing the building, and ran into the wooded area behind the facility, heading west. Officers scoured the immediate vicinity of Woodridge and were unable to locate either male subject.

Ms. Brumley gave the following description of the juveniles:

██████████, described as ██████ tall, weighing ██████ pounds, bi-racial, male, wearing a black skull cap, gray shirt, black jacket, blue jeans, and gray tennis shoes. ██████ also goes by the name ██████

██████████ is described as ██████ weighing ██████ pounds, black male, with a low haircut. The only clothing description provided was a navy blue shirt, with a graphic design.
