On 7-23-2020 I Officer Adrian Todd was dispatched to WoodRidge 603 Kittle Rd in reference to 2 juvenile runaways. Upon arrival I spoke with the staff who stated that [REDACTED] and [REDACTED] had escaped. I remembered the juveniles from 7-22-2020, due to the 2 boys escaping twice within approx 10 mins. I was advised by dispatch that the 2 boys went back to the facility on their own, which was 2 hrs of them running away. I made contact with the nurse at WoodRidge and observed both juveniles wearing green scrub pants only. When the juveniles left the building they did not have on shoes nor did they have a shirt on.
