On 7-25-20 at approximately 9:44pm Officers were dispatched to 603 Kittle Rd. Woodridge Behavioral Center for four juveniles that had escaped the facility by disabling the north east door and prying it open. All four were later located and returned to Woodridge. At around 12:30am on 7-26-20 the same four juveniles escaped the facility again by kicking the northwest door open. Contact was made with staff to attempt to get clothing descriptions but the only one that was seen by the staff member was [REDACTED] who was wearing a black hoodie and black jeans. Another one of the boys [REDACTED] who was returned earlier was wearing a grey t shirt and black shorts with no shoes. Direction of travel is not known and none of the juveniles have returned at this time. They were all entered into ACIC as missing juveniles.
