**Narrative**

On Monday, August 10, 2020 at approximately 1348 hours, I was dispatched to 161 Skunk Hollow (Little Creek Behavioral Hospital) in reference to battery.

When I arrived on scene I spoke to Dr. John Leach (victim) who stated he had been attacked by JV1 (offender). He stated that earlier in the day JV1 had stated he wanted to go to a hospital to get out of Little Creek. He stated JV1 was mad when he was not removed from Little Creek.

Dr. Leach stated that at JV1 had gotten away from his one on one caregiver, Mr. Staffone Marshall (others involved), then ran to the other side of the room and attacked him. Punching him in the head, face neck and shoulder multiple times. Dr. Leach stated he took JV1 to the ground and JV1 kned him in the back of the head. Dr. Leach stated he called for help and staff pulled JV1 off.

Dr. Leach had a cut on his face/ nose, red areas/ bruising on his face and neck and a knot on the back of his head. He was complaining of head and shoulder pain. He refused medical and stated an on staff nurse would treat him. JV1 told staff that he had meant to hurt Dr. Leach because he would not listen to him.

I spoke to Officer Franklin with Juvenile Probation who advised me to transport JV1 to Unit 1 Juvenile detention center. I transported JV1 to Unit 1. I issued a citation for Battery 3rd "C219617". Dr. Leach was advised of the report number.

Dr Leach and Mr. Staffone wrote statements and they were placed in the case file. Photographs were taken and added to patrol pics. My body worn camera was on during my investigation.

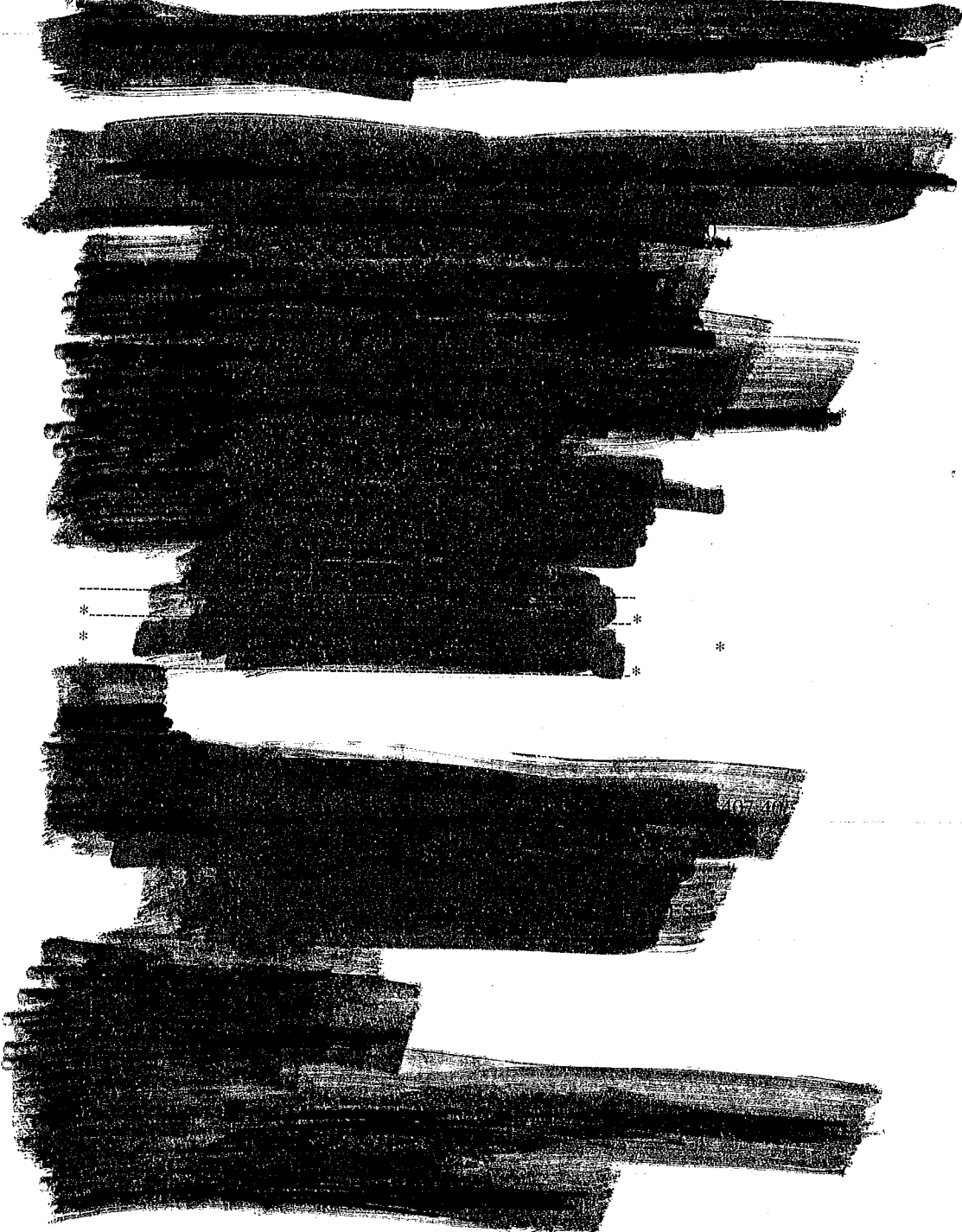
