## Narrative

On Wednesday, August 19, 2020 approximately 2204 hours (10:04 pm) I was dispatched with a call for service regarding battery occurring approximate date 08/11/2020. I made contact with Ms. Jodi Loosley (Complainant) via phone call. Dispatch was unable to locate Ms. Loosley in NCIC/ACIC.

Ms. Loosley explained JV1 (Victim) is staying at Little Creek Behavioral Health (Offender). JV1 was assaulted last week approximately 08/11/2020. Little Creek contacted Ms. Loosley and advised her JV1 was having X-Rays completed but everything was okay. Ms. Loosley became concerned and started making inquiries into the situation. Ms. Loosley decided to take JV1 away from the facility and move him elsewhere. Ms. Loosley made the appropriate steps to remove JV1 from the facility. Ms. Loosley wanted me to accompany her to Little Creek Behavioral to ensure a smooth transaction and record the event. I informed Ms. Loosley I could not disobey a judges judgment. Ms. Loosley stated she understood. Little Creek Behavioral released JV1 to Ms. Loosley and advised they would attempt to get her all required and request reports. I gave this report number to Ms. Loosley and explained how to obtain a copy. I explained to Ms. Loosley she could talk to the Prosecuting Attorney about the situation.
