I made contact with JV1 and her stated that JO1-5 did not like him so they jumped him and beat him up.

I made contact with Ms. Johnson and she stated JO6 physically assaulted her by punching her in the stomach. Ms. Johnson stated when she walked into the boys room they were all fighting. I verified with Ms. Johnson that JV1 was not trying to hurt her and she stated they were all fighting when she walked in the room.

I was informed that JO6 kicked and spit on Trooper Carlton.

I made contact with Mr. Wilson and informed him of the findings of my investigation.

All juveniles involved had minor injuries and MEMS came to this location.

I gave Mr. William an incident number and informed him how to obtain a copy of the report.
