**Narrative**

On 8/29/20, I was dispatched to 161 Skunk Hollow Rd to the Little Creek Behavior Hospital. La'Shonda Johnson (complainant/victim) stated that they needed a report for an assault and property damage.

Once on scene, I made contact with Ms. Johnson and Reginald Reyford (others). Ms. Johnson stated that JO1 hit her in the back of the head while she was trying to break up JO1 and JO2 from arguing.

Mr. Reyford stated that he witnessed JO1 attack Ms. Johnson while attempting to break up an argument.

Keyanna Johnson (others) was not on scene when I arrived but provided a written statement along with Mr. Reyford and Ms. L. Johnson

During the argument JO2 destroyed 2 HP computer monitors and a Riecho Printer. Ms. Johnson said the damages to the printer were approximately \$500 but the printer costs around \$5000. But the Monitors were completely destroyed and were around \$250 a piece.

Ms. L. Johnson and Mr. Reyford also provided written statements.
