**Narrative - Kennedy, Jordon Lee - 8/31/2020 (Initial)**

On Friday August 28, 2020 I was contacted by Dacus in reference to a juvenile assaulting other juveniles and staff. When I arrived on scene I made contact with staff and was informed that [REDACTED] had caused injury to another juvenile and was breaking things inside the facility. I made contact with Juvenile Probation and was told to transport [REDACTED] to the Craighead County Juvenile Detention Center. There is no further information at this time.
