Narrative

On Tuesday, September 8, 2020, I was dispatched to 161 Skunk Hollow Rd to take a battery report. I arrived on scene and made contact with Mr. Carlos Silva (complainant). Mr. Silva is a supervisor for the facility.

Mr. Silva stated he needed to make a battery report. Mr. Silva showed me the video footage of the incident and gave me incident statements from the facility for the employees involved. I advised Mr. Silva that I needed additional information from the employees and he called them to the front to provide me the information I needed.

Ms. Johnson (victim) stated JV1 (offender) got upset with her teacher in the classroom and walked out. She stated staff gave JV1 several directives to comply and go back in the class. Ms. Johnson stated JV1 refused and began to make threats towards the staff. She stated additional staff was called. Ms. Johnson stated JV1 then walked towards her and started pulling her hair and punching her in the face. She stated Mr. Dennis Brunson (OI) managed to pull JV1 off of her.

Mr. Brunson stated he was called out of class due to JV1 refusing to return to class. He stated JV1 proceeded to make threats towards Ms. Johnson. Mr. Brunson stated JV1 attacked Ms. Johnson and started hitting her. He stated he was able to pull JV1 from Ms. Johnson.

I gave all parties the report number and advised them how to obtain a copy. I explained the warrants process to Mr. Silva in order for charges to be filed against JV1.

The information gathering was captured on my issued Body Worn Camera. The video evidence was added to the patrol photos file for the report.




