



| | Narrative |

On Tuesday, September 29, 2020, I was dispatched to 161 Skunk Hollow Rd. (Little Creek Behavioral Health) to take a Battery report. I arrived on scene and made contact with Mr. Carlos Silva (complainant) and Mr. Jordan Dozier (victim) in the lobby.

He stated that Mr. Dozier Mr. Silva stated that Mr. Dozier was attacked by JV1 (offender) and is under his supervision in the company and the incident was caught on security camera. Mr. Silva provided me the video of the incident.

Mr. Dozier stated that while on recreation time, both JV1 and Mr. Abdul-Haqq stated once they get a chance they are going to "turn up". He stated JV1 came in and started throwing tables around. Mr. Dozier stated he immediately radioed for assistance immediately. He stated both offenders grabbed him and tried to get his radio and to pull him off of camera but he was able to maintain his radio in his possession and stay in camera view. Mr. Dozier stated they started hitting him and JV1 put him in a choke hold. He stated that he never lost consciousness or lost his airway. Mr. Dozier stated assistance arrived shortly after the altercation began. He refused medical attention,

I gave both Mr. Silva and Mr. Dozier the report number and advised them how to obtain a copy. I placed the video evidence in the Patrol Photos file for this report. I explained to both parties the warrants process in order to file charges against the offenders.
